With this innovative option, you can store cardholder data within the Orbital Payment Gateway as a customer profile that can be retrieved and accessed through the secure Payment Gateway and Virtual Terminal.

How it Works

You provide your customer's contact information, credit card or payment account information and a unique profile number. Once you create a profile, you can process transactions by simply using the assigned profile number to represent that customer.

Customer Profile Management lets you build a database of your customers that you can access through the Orbital Payment Gateway and Virtual Terminal for repeat customer transactions. You can retrieve your customer's information at any time to process a transaction, update data fields or inactivate a customer profile.

You also control how your employees access this information by assigning different levels of control: "change rights," "read only" or "no access." Any other Orbital user access levels you have established will not be impacted by the profile access levels. For instance, if a user cannot submit credits, they will not be able to submit credits using the Profiles module.

Profile payment account data can be submitted for credit cards. PINless debit cards, European Direct Debit, U.K. Maestro cards and electronic checks.
