The Health Benefit Card BIN Range Delimited File consists of all Visa and MasterCard BIN ranges provided to Chase Paymentech at the time the file is created. Chase Paymentech is not responsible for errors or omissions.

The default file name is HBINP.V001.mmddyyyy.*, where the * could be, T (tab delimited), P (pipe delimited), C (comma delimited).
