## **Safetech Agent Web Console Version 5.5 Release**

---

In this release, the focus is on enhancements to the VIP Lists. You can also expect an additional update to the Mobile App SDK (Android only).

### **New Payment Item in VIP List**

---

In VIP lists, items CREDIT CARD and GIFT CARD both appeared in previous versions. In the current version, all payment types have been combined into a single item called PAYMENTS. **Only** payment types that generate a unique identifier can be used for the VIP list menu.

### **Payment Type and VIP List Change in Rules Engine**

---

Rules can be written around both payment type and VIP list items for these new payment types and changes have been made in the Rules Engine to allow writing new rules based on these changes.

### **Mobile SDK for Android**

---

Android Mobile SDK 2.0 is released with this version of Safetech Fraud Tools. For merchants planning to collect Geo Location and Device ID/Fingerprint data in their mobile application, the Android Mobile SDK 2.0 is using new and additional capabilities to harvest this data by utilizing the native Android libraries. Contact Merchant Services or your Account Executive for assistance and to take delivery of this SDK.
